Sir,

I am directed to convey the approval of the Board for revision of completion schedule for laying, building, operating or expanding Kochi-Coimbatore-Erode-Salem LPG Pipeline (KSPPL) of M/s Kochi Salem Pipeline Private Limited. Considering the state of unprecedented socio-political hindrance in execution of KSPPL project, PNGRB has decided to revise the completion schedule of aforesaid pipeline from February 2017 to February 2019.

2. Accordingly, Clause No. 2 of PNGRB Letter No. Infra/PL/PPL/BID/KCSPL/01/2014 dated 26.02.2014 stands revised as under:

“The entity shall complete the activities of laying, building or expansion activities of Petroleum and Petroleum Products Pipeline and commission the Petroleum and Petroleum Products Pipeline project by February 2019 including rerouting of pipeline and addition of Palakkad tap-off terminal as decided by the

Board. Any failure on the part of the entity in complying with the targets prescribed in the time schedule shall lead to consequences as specified under Regulation 16 of the Petroleum and Natural Gas Regulatory Board (*Authorizing Entities to Lay, Build, Operate or Expand Petroleum and Petroleum Products Pipelines*) Regulations, 2010”

3. All other terms and conditions stipulated in letter No. Infra/PL/PPL/BID/KCSPL/01/2014 dated 26.02.2014 shall remain the same.

4. In view of the above, M/s Kochi Salem Pipeline Private Limited is hereby requested to acknowledge the receipt of this letter as an acceptance of the above mentioned amendments.
